Call to Order

The Annual Meeting of the Tennessee City Management Association was called to order by President Ted Rogers at 12:15 p.m. in the Nashville Room of the Sheraton Memphis Downtown, Memphis Tennessee.

Upon motion and second, the recommended slate of candidates was unanimously elected.

Transfer of Leadership to the New President and Comments

President Stuckey presented a plaque to Mr. Rogers and thanked him for serving as president during the past year. President Stuckey challenged the members to deliver a great ICMA conference this year which he noted will be supported by the strong resources and capacity that TCMA has put into place. He also noted that ongoing TCMA resources are strong allowing the Association to invest in professional development opportunities and advance new initiatives such as next generation of managers and advocacy/legislative support.

Presentation of Fiscal 2020 Budget

Executive Director Broughton reviewed the adopted FY 2020 budget which provides for \$462,665 in spending during the year. Included in the total is the General Fund of \$104,129 and the ICMA Conference Fund of \$358,536. Broughton noted that each fund was balanced with the General Fund projected to generate a net income that would be added to fund balance reserves, while the ICMA Conference Fund will be fully expended with conclusion of the ICMA conference that takes place during the fiscal year.

President Stuckey reminded the membership of the need to populate the eight TCMA committees with a general call-out to be forthcoming from the executive director to ascertain member interest in serving on the following committees:

Executive Director's Report

Executive Director Broughton shared general information with the membership on areas of interest including TCMA member and sponsorship numbers, the ICMA Membership Initiative, the TCMA social event at the upcoming ICMA conference, and the TCMA Spring 2020 conference.

Project Manager's Report

Project Manager Mike Walker updated members of the status of planning and fund raising for the ICMA 2019 Annual Conference in Nashville. He noted that direct conference support from TCMA will be approximately \$310,000.

Members were reminded to attend the TML district meetings and support the appointment of district advisors that are positioned by knowledge and experience to assist the TML board and staff on legislative matters that arise.
